Marin County Triathlon, Sunday, October 26, 7am-1pm—

Based at McNear's Beach

Parts of North San Pedro Road will be subject to traffic control including temporary road closures between 7am and 1pm on Sunday, October 26 to accommodate the bike and run portions of the Marin County Triathlon. The event will be based at McNear's Beach Park. The cycling course begins at McNear's and runs north up North San Pedro Road, turns right at the Civic Center and follows Redwood Highway to Smith Ranch Road. The course then turns left onto Lucas Valley Road, and turns around at the 12.4 mark at Westgate Drive with California Highway Patrol providing traffic control.

Eastbound Point San Pedro Road at Riviera Drive will be closed and eastbound traffic will be detoured onto Riviera Drive to Biscayne. There is no through access around China Camp State Park, but the Peacock Gap Golf Course is accessible and all residents can get to and from their houses. Course closure will also affect North San Pedro Road from the County limits at the southern end of China Camp State Park west to just beyond the Miwok Meadows fire road.

An encroachment permit was issued on the following conditions: traffic control shall be provided at the organizer's expense and approved by the CHP and Sheriff, access shall be maintained at all times for emergency vehicles and residents, signs and barricades shall be placed to denote road closures and redirect traffic, and all liter and debris shall be removed immediately upon the conclusion of the event.

Civic Center Lagoon Park. Playground Now Open

The old, worn out Civic Center Park Playground has become a new state of the art children's playground. Bold, innovative designs of the playground equipment has been incorporated into a parent/child friendly atmosphere that breaks new ground for playground design in the future.

Steve Petterle, park principle planner, and Nancy Peake, park planner, have skillfully guided the renovation project through the design and planning process.

"We have attempted to create a new playground that will honor the special architectural relationship with the Frank Lloyd Wright Civic Center. We are hoping that children will want to put down their Play Station games in exchange for some quality outdoor time exploring and using the innovative playground equipment," said Steve Petterle. "We see this playground as a destination point for children and parents throughout Marin County."

The playground features imaginative playground equip-

ment such as; The Arcturus, a climbing structure that looks as if it came directly out of a Salvador Dali painting; The Blazer, a three person spring device; the Supernova, a round, undulating, spinning play structure; and the Spica spinner, designed for the individual child to hop on and spin away at there own speed. There are also two different sets of swings, one set for toddlers and the other set for older children.

An innovative sand play area and meandering creek water feature are also part of the playground. Kids love the hands-on approach to fun and this feature should provide that experience.

Parents will find refuge from the laughter and playground area by moving over to the central area known as Picnic Plaza. Here parents can converse with other parents, have a snack, or relax while still keeping a watchful eye on the kids at play.

"What an exciting experience to see the playground design move from the drawing board through construction to completion in such a short period of time. The design is vibrant, creative and fun," said Nancy Peake.

"That's simple, John. Check out the list below for the various locations in the Bay Area that will take that old used electronic equipment and recycle or rehabilitate it. All we have to do is just drop the stuff off. Check it out..."

Save your acorns! Plant a tree

with Marin ReLeaf.

Acorns are needed for planting at China Camp State Park and elsewhere in Marin County.

Nuts are ready for harvest usually in October.

Shake the acorns off the branches of naturally occurring trees. Nuts from these trees are best adapted for Marin's soils and climate rather than those planted from nursery stock.



Remove the nut caps

Save your acorns!

Toss the nuts into a bucket of water

Keep the nuts that sink to the bottom after minute.

Toss the others out for wild life.

They have air holes, probably from an insect.

Designed to be a community gathering spot, the Campus is a place to not only seek help and care, but also a place to learn and experience wellness. The open space around the buildings, the interior courtyard, the gardens, a water feature and close proximity to community trails and gardens, contribute to an inviting and welcoming environment.

None of this would have been possible without the Board of Supervisors and CAO's commitment to quality, accessible health care for all. As **Supervisor Susan Adams** expressed, "The heart and health of a community is measured by whether *all* have access to healthy living."

Using one-time-only Tobacco Master Settlement funding, the dream of co-locating Marin Community Clinics and Health and Human Services in order to better coordinate clinical and prevention services is now a reality. Over 64,000 square feet in five buildings on Kerner at Bellam, plus an additional building on Kerner, were renovated to create this innovative one-stop access point to a spectrum of services, clinics and programs.

And, it's "green"! The Campus is integrating state of the art environmentally friendly building practices for design, construction and site operation. This commitment includes:

Re-use and recycling of materials and supplies during construction, use of solar energy, landscaping with native plants to minimize water use, energy-efficient heating, ventilation and cooling systems, and extensive on-site recycling
