### It's Time for Winter Preparations in Santa Venetia

Marin County has received its first significant rains of the season this past week (upwards of 2 inches) and we thought that it would be a good time to let Santa Venetia residents know about our preparations for the upcoming rainy season.

All stormwater pump stations have been inspected and maintained as necessary. Additionally, portable pumps have been serviced and deployed. Vegetation and debris from creeks/ditches have also been cleared to help prevent blockages.

While one sweep to eradicate rodents from the Santa Venetia Marsh Open Space levees has been conducted, additional spot trapping will continue and burrows filled as needed. Please contact Bene DaSilva at **415-473-6538** to report gopher concerns at the Santa Venetia Marsh levee and for more information on the program.

County Roads will be performing their annual street storm drain cleaning following the leaf drop, which is anticipated to occur within the next few weeks. Keep a lookout for the large vactor truck which is used to remove debris from the system.

If you have a flood control related concern you may report it during normal business hours (Mon-Fri, 8 am – 5 pm) by dialing **415-473-6528**. After hours **emergencies** may be reported by dialing **415-473-7513**.

### Mt. Tam Lookout Experienced by Gifted Videographer

We wanted to share some great information about the video that volunteer Fire Lookout and videographer Gary Yost passed along. The video is now being viewed internationally and is viral!

- There's a website in Poland that featured the piece and get this... out of the 11,000 people who loaded it, 10,000 watched it through to the last frame. That's almost 1:1!, a remarkable indication of its impact on the viewers.
- There have now been 480,000 loads of this video and 61,000 people have watched it all the way through to the final frame. It took off big time last Thursday when the site laughingsquid.com found it. At this point at least 300 different websites have featured it.
- Nikon World magazine confirmed that they're going to do that feature for the winter issue, and I should be hearing from them in early November.

Gary also reports that the Madrid Film Festival in Spain asked his permission to show his video there, Gary said yes. It will be projected on a 70 foot wide screen for everyone to see.

### **County Continues Commitment to Road Improvements**

The Metropolitan Transportation Commission recently released its annual report on Bay Area Pavement Conditions. Though Marin remains in the "at-risk" category with a *3-year average* Pavement Condition Index (PCI) of 52, we are making good progress. The PCI is a rating system that assigns a number value to reflect road condition where a PCI of 0 is a gravel road and a PCI of 100 is a newly constructed street. Marin County's 2011 PCI is a 54, which is a 12.5% increase since 2006 when the PCI was 48. This improvement can be attributed to the Board of Supervisors' strong commitment of local funds coupled with County's aggressive pursuit of State and Federal grants to fund almost \$50M in road improvement programs since 2006. Commensurate with this level of investment, the County is striving for a 1 to 2 point PCI increase per year.

On the heels of the recently completed 2006-2010 \$20.5M five-year program, the Board of Supervisors committed funding to a new 5-year program – the \$26M 2011-2015 Road Improvement Program. Public Works staff hopes to accelerate delivery of the 2011-2015 Program to 2014 to make way for more road improvement projects.

In 2012, the Marin County Department of Public Works resurfaced 26 miles of roadway to include 17 miles of roadway seal coats and 9 miles of roadway reconstruction, which was done at the cost of \$6M.

## Marinwood Village Community-Wide Open House Held

On Saturday, October 27 interested residents attended a late morning community-wide open house held at the Mary Silviera Elementary School Community Room. The main topics of discussion were the development and design features that may be incorporated in the proposed Marinwood Village mixed use project. The proposed Marinwood Village project is located at the site of the former Marinwood Shopping Center.

Those in attendance were given index cards and asked to provide input and suggestions regarding their preference in design elements, architectural styles, and the suggested layout of the project itself.

The workshop allowed those in attendance to directly communicate with the two representatives of BRIDGE Housing, a property management company, which is the lead developer for the project. The BRIDGE vision for the site consists of the current Marinwood Market, additional retail outlets, affordable and market rate residential units and the retention of the popular Saturday Farmers' market.

County planning staff were available to answer questions concerning the planning process that resulted in the adoption of the Marinwood Conceptual Master Plan by the Marin County Board of Supervisors. Supervisor Susan Adams was also present to help guide the meeting along.

A lively discussion among some of those in attendance developed concerning aspects of the proposal. Among the concerns expressed were traffic, intersection improvements, impacts to the local public school system, the streetscape, parking, the size of the housing structures, among other issues.

Since this workshop was designed as an informational gathering process the possibility of a larger question and answer period was limited. The representatives from BRIDGE recorded the comments and will provide a more detailed response during the next community-wide meeting set for sometime in December.

Supervisor Adams is dedicated to opening up the planning process for additional public input and discussion. Please be looking for the public notices announcing the next community-wide meeting coming soon. Also, BRIDGE is working on a website and we will let you know once it is online.


