Project Title: North Marin Water District (NMWD) Territorial Boundary Adjustment
Project Location: Inverness Park and Marshal Areas of western Marin County CA

Specific: NMWD, in cooperation with the Inverness Public Utility District (IPUD) and Marin LAFCO, is proposing to adjust its territorial boundary in the West Marin Water Service Area to detach the boundary of IPUD. In addition, NMWD is proposing to detach the Marshall Area from its overall jurisdictional boundary since NMWD has never provided nor currently can provide, water or sewer services to the parcels located within the area.

Project Location-City: Inverness Park and Marshall Areas of unincorporated Marin County

Project Location-County: Marin County

Description of Nature, Purpose, and Beneficiaries of Project: This project includes the following components:

- Detachment of the NMWD Marshall Service Area from the NMWD Territory
- Adjustment of the NMWD West Marin Water Service Area to detach the Inverness Public Utility District's boundary from the NMWD boundary.
