MEMORANDUM OF UNDERSTANDING BY AND BETWEEN CALIFORNIA CONSTRUCTION AUTHORITY AND THE COUNTY OF MARIN

This Memorandum is entered into effective this 22nd day of August 2006 by and between the California Fairs Financing Authority doing business as California Construction Authority, a joint powers authority ("CCA") and the County of Marin, a County in the State of California ("County").

Whereas CCA and the County desire to enter into this agreement to specify the manner in which certain services which benefits the County will be performed by CCA.

Now therefore the parties hereto hereby agree as follows:

- 1. Designation of Projects: The County may from time to time provide written Letters of Understanding to CCA designating specific services to be undertaken by CCA, the time for completion of said services and the compensation to be paid by the County to CCA for the performance of said services. Each Letter of Understanding shall also specify such interim approvals as are determined appropriate by County. A sample of a Letter of Understanding is attached hereto as Exhibit "A". Each Letter of Understanding shall be delivered to CCA and shall provide for a signature by CCA and County. CCA shall sign and return the Letter of Understanding in the event CCA is willing to perform the services set forth in the Letter of Understanding within the time and for the compensation specified in the Letter of Understanding.
- 2. Scope of Services: CCA shall provide those services that are specified in an approved Letter of Understanding.
- 3. Bidding: In the event CCA contracts for work specified in a Letter of Understanding, CCA may use the bidding procedures applicable to CCA.
- 4. Access to Documents: CCA agrees that all notes, designs, drawings, specifications and other technical data produced pursuant to a Letter of Understanding shall be made available to the County.
- 5. Audit: The County shall have the right to audit the books and records of CCA relating to services performed pursuant to a Letter of Understanding. Said audit shall be conducted if at all within two years following the date of completion of the services specified in the subject Letter of Understanding.
- 6. All Letters of Understanding shall be signed by the President of the Board of Supervisors as the authorizing officer.
- 7. Termination: Either party may terminate this Memorandum by giving the other party not less than thirty (30) days prior written notice of termination. This Memorandum shall remain in force until terminated. Upon termination the County shall compensate CCA for all services satisfactorily performed prior to termination.
