**SUMMARY:** The grant award will fund a collaborative project to provide training to Marin County

law enforcement, prosecutors and court officers. The training will enhance their ability to identify, investigate and prosecute incidences of abuse, neglect and sexual assault against elder individuals and individuals with disabilities. The District Attorney's Office will provide fiscal oversight for the program, as well as a program trainer.

H&HS Division of Aging will provide project leadership and organize team member work by coordinating training activities with the support of an Elder Abuse Training Program Coordinator, a 0.50 FTE position funded by the grant. Among the activities to be funded by the grant:

- Training for 242 officers from seven law enforcement agencies in the County, representing 57% of all law enforcement officers;
- Training will also include 15 prosecuting attorneys from the District Attorney's Office, 6 social workers from Adult Protective Services, and 4 probation officers from the Marin County Probation Department.
- 2 of the County's judges will be able to attend a national judicial training on elder abuse, neglect and exploitation.

**COMMUNITY BENEFIT:** The Elder Abuse Training Program will train criminal justice system personnel on elder abuse issues and will address the barriers faced by older victims and victims with disabilities. The program will help to improve the local criminal justice response to these members of the community.

**FISCAL IMPACT:** The District Attorney will re-direct an existing 0.25 FTE Prosecuting Attorney position. The result will be a reduction in net county cost of \$34,990 in the first year of the grant. It is anticipated that years 2 and 3 of the grant will result in a net cost reduction of \$48,500 each year.
