



SECOND ADDENDUM TO AGREEMENT

BY AND BETWEEN THE
COUNTY OF MARIN AND HARRIS & ASSOCIATES DATED JUNE 6, 2006

THIS ADDENDUM is made and entered into this 9th day of January, 2007, by and between the COUNTY OF MARIN, a political subdivision of the State of California (hereinafter referred to as "County") and HARRIS & ASSOCIATES (hereinafter referred to as "Contractor").

RECITALS

WHEREAS, the County and the Contractor entered into an agreement for repair of storm damage sites dated June 6, 2006 ("Agreement"); and

WHEREAS, the agreement was subsequently amended on August 15, 2006; and

WHEREAS, Section 4 and Exhibit A to the amended agreement obligated Contractor to provide services set forth in Exhibit A for the compensation of \$865,000; and

WHEREAS, the parties desire to amend the agreement to increase the services to be provided by adding additional sites;

NOW, THEREFORE, the parties agree to modify Section 4 and Exhibit A as set forth below.

AGREEMENT

1. Except as otherwise provided herein all terms and conditions of the agreement shall remain in full force and effect.

3. Section 4 and Exhibit A are hereby amended to read as follows

Section 4 – Maximum Cost to County

In no event will the cost to County for the services to be provided herein exceed the maximum sum of \$1,125,000.

EXHIBIT A
SCOPE OF SERVICES

Provide project management, geotechnical engineering, engineering design and construction management services for designated storm damage sites on County roads including but not limited to: coordinating with County staff on project implementation, evaluating alternative design concepts, performing soils engineering, preparing detailed design drawings suitable for bidding, providing project specifications, preparing cost estimates, conducting weekly meetings, analyzing issues and making recommendations; evaluating shop submittals, change orders, progress payments; assist in dispute resolution when necessary; observe and monitor aspects of the project, notifying contractor of defective work requiring correction; review and monitor contractor's safety program; make final inspections and prepare punch lists, verify submittal of as-built plans, O&M manuals and certificates of compliance; process final payment request; file notice of completion if required; deliver all project records to the County of Marin.
