REQUESTING THE MARIN COUNTY BOARD OF SUPERVISORS TO AUTHORIZE THE REGISTRAR OF VOTERS TO PROVIDE SERVICES AND TO CONSOLIDATE REQUESTING JURISDICTIONS WITH THE SPECIAL ELECTION TO BE HELD ON MARCH 6, 2007

WHEREAS the Ross School District and County Service Area No. 29 in the County of Marin have passed resolutions requesting consolidation with the Special Election to be held on March 6, 2007; and

WHEREAS Section 10400, et seq., of the California Elections code provides that whenever two or more elections of any legislative or congressional district, public district, city, town, county or other political subdivision are called to be held on the same day in the same territory, or in territory that is in part the same, they may be consolidated; and

WHEREAS, pursuant to Section 10002 of the Elections Code, the governing bodies may request the Board of Supervisors to permit the Registrar of Voters to provide specified election services to such jurisdictions on a reimbursable basis;

NOW; THEREFORE, BE IT RESOLVED that an election has been called to be held on March 6, 2007 for the purpose of submitting to the qualified electors of the Ross School District and CSA 29 the following measures(s), to wit:

ROSS SCHOOL DISTRICT MEASURE A

To maintain small class size, science, technology, library, fine arts, Spanish, learning lab and other programs, shall the Ross School District extend its previously approved	YES
parcel tax for a period of eight (8) years at the rate of \$626.98 in the first year, and at such rate plus an annual 3% cost-of-living adjustment for each year thereafter, beginning July 1, 2007, with exemptions available for property owners age 65 or older?	

COUNTY SERVICE AREA 29 MEASURE B

Shall the existing parcel tax of Nine Hundred Twenty Five Dollars (\$925.00) on each	
parcel be increased to One Thousand Two Hundred Dollars (\$1,200.00) within County	YES
Service Area No. 29 annually and extended for a period of ten (10) years,	
commencing in FY 2007-2008, terminating in FY 2017-2018, to provide funds for	NO
ongoing maintenance dredging in the principal waterways of Paradise Cay along with	
the north and south entry channels to San Francisco Bay?	

THAT the Board of Supervisors has been requested to approve the consolidation of said District and School with the March 6, 2007 Election; and

THAT the Registrar of Voters shall provide services and the said election shall be conducted and canvassed in the same manner as all other elections held on that date.
