

SECOND ADDENDUM TO AGREEMENT

BY AND BETWEEN THE COUNTY OF MARIN AND LILBURN CORPORATION

THIS SECOND ADDENDUM is made and entered into on June 19, 2007, by and between the COUNTY OF MARIN, a political subdivision of the State of California (hereinafter referred to as "County") and LILBURN CORPORATION (hereinafter referred to as "Contractor")

RECITALS

WHEREAS, the County and the Contractor entered into an agreement for **expert quarry** and surface mining services to review San Rafael Rock Quarry amended reclamation plan dated June 22, 2004 ("Agreement"); and

WHEREAS, Sections 6 and 14 regarding Time of Agreement, as first amended on April 25, 2006 to the agreement obligated Contractor to; terminate the agreement on June 30, 2007

and

WHEREAS, the parties desire to amend the agreement to **extend the termination date** to **December 31, 2008,**

NOW, THEREFORE, the parties agree to modify **Sections 6 and 14**, as set forth below.

AGREEMENT

- 1. Except as otherwise provided herein all terms and conditions of the agreement shall remain in full force and effect.

- 3. Sections 6 and 14, is/are hereby amended to read as follows:

Section 6: All work required for this Contract shall be completed and ready for acceptance no later than December 31, 2008. Section 14: This Agreement shall commence on June 22, 2004 and shall terminate on December 31, 2008.
