### **RECOMMENDATION:**

Authorize the President to execute amendments to the current agreement with Alcalde & Fay, Ltd. for an additional one-year of representation services in Washington, D.C.

#### SUMMARY

The County receives significant assistance in pursuing its legislative and programmatic goals in our federal capitol from Alcalde & Fay, Ltd. in Arlington, Virginia.

The proposed agreement provides for payments of \$6,500 per month (\$78,000 annually) plus expenses (if any) effective January 1, 2012 through December 31, 2012. This contract amount is unchanged from the previous year.

# AMENDED AGREEMENT FOR PERFORMANCE OF LIMITED PROFESSIONAL FEDERAL LEGISLATIVE SERVICES

This Amended Agreement is hereby made and entered into this 20th day of <u>December</u>, <u>2011</u>, by and between the COUNTY OF MARIN, a political subdivision of the State of California, (hereinafter referred to as "County"), and ALCALDE & FAY, LTD. (hereinafter referred to as "Contractor").

### WITNESSETH:

The Agreement for Performance of Limited Professional Federal Legislative Services entered into by County and Contractor on the 20th day of December, 1994, is hereby amended to read as follows:

### 2. Compensation and Expenses

- a. As compensation for services to be rendered hereunder, County shall pay to Contractor a monthly fee of \$6,500 beginning January 1, 2012, payable upon receipt of an invoice from Contractor.
- b. In addition to the compensation specified in Section 2a., Contractor shall be reimbursed for travel to Marin, telephone calls to Marin (including faxes), overnight delivery charges, and other such incidental charges. Any single expense in excess of Three Hundred Dollars (\$300.00), or any expenses totaling Five Hundred Dollars (\$500.00) in any month, must be approved in advance by the Marin County Administrator.
- c. The County Administrator or his designee shall be the County's representative for purposes of administering this Agreement.

## 6. Terms of this Agreement and Termination

Clerk, Board of Supervisors

- a. This Agreement may be terminated by either party upon thirty (30) days written notice. In the event of termination, Contractor's compensation shall be limited to the amount due on a pro rata basis as of the date of termination.
- b. Unless terminated under Section 6a, this Agreement shall end on December 31, 2012.

All other terms and provisions of said Agreement shall remain in full force and effect.
